TERMS OF SERVICE. WELCOME TO YOUR PLANET! PLANET LABS INC ("PLANET") IS EXCITED TO MAKE THE PLANET EXPLORER, OUR APIS, AND CONTENT AVAILABLE TO YOU (COLLECTIVELY, OUR "CONTENT"). THESE TERMS OUTLINE YOUR RIGHTS AND RESPONSIBILITIES WHEN USING OUR CONTENT. BY ACCESSING THE CONTENT, YOU, ON BEHALF OF YOURSELF OR YOUR ORGANIZATION (HEREINAFTER "YOU", "YOUR"), ARE EXPRESSLY AGREEING TO BE BOUND BY THE TERMS AND CONDITIONS OF PLANET EXPLORER TERMS OF SERVICE, IN ADDITION TO THE WWW.PLANET.COM TERMS OF USE AND PRIVACY POLICY (COLLECTIVELY, THIS "AGREEMENT").
