Planet Labs PBC (together with its affiliates, "**Planet**") is committed to establishing and adopting company practices that reflect and uphold Planet's core value of environmental stewardship.

This enterprise level Environmental Stewardship Policy (the "**Policy**") contains general guidelines for, and applies to, all Planet directors, employees, contractors, suppliers and vendors and others who may formally act on Planet's behalf. Where this Policy sets standards higher than required by applicable law, we expect compliance with this Policy.

As a Public Benefit Corporation, Planet's purpose is to accelerate humanity toward a more sustainable, secure and prosperous world by illuminating the most important forms of environmental and social change. This Policy is one way in which we work to put our purpose, values, and commitments into practice.

Environmental Stewardship Objectives

Mitigating Climate Change. Planet is deeply concerned about the effects of climate change on Earth's natural ecosystems and environment, and works with our customers, partners, local communities and researchers to illuminate these effects through continuously updated satellite data. Through these partnerships, we hope to empower our users to help mitigate the negative effects of climate and environmental change on Earth.

Engaging with the Natural World. Planet recognizes the value of maintaining Earth's natural capital, biodiversity, and ecological health, and is committed to:

- promoting and prioritizing the use of Planet's imagery data and derived products to address environmental issues around the world (such as through promoting and enabling agriculture and water management, climate change and risk assessment, sustainability monitoring and disaster response, etc.);

- complying with environmental laws, regulations, and other requirements relevant to our business;
- providing adequate resources for environmental stewardship and closely monitoring our business administration and processes to ensure that our operations are effectively managed and that environmental risks are mitigated;
- actively engaging with key stakeholders on environmental issues; and
- procuring materials and services that are less greenhouse-gas intensive and/or environmentally beneficial.

Advocating for Space. Protecting the space environment is not only of importance to our operations as a satellite operator, but we consider it of utmost importance to humanity's short-term and long-term success. Planet is committed to being a strong advocate for promoting sustainable and responsible use of the space environment, including as it relates to orbital space debris, kinetic anti-satellite activity, space situational awareness for transparent and collaborative space traffic management and responsible de-orbiting of satellites.

Measuring and Improving. At Planet, we believe you can't manage what you don't measure. This is not only what our product can bring to our customers, but a truth that we internalize. Planet is committed to measuring and evaluating our own environmental impacts (including greenhouse gas emissions) on a regular basis, including against stated commitments and targets to reduce these impacts, and identifying opportunities to improve our outcomes and establishing and maintaining an environmental management system. By doing so we hope to continuously improve our environmental performance, including energy, water, and waste management within our operations.

Planet recognizes that we must continue to challenge ourselves to ensure our Environmental Stewardship Objectives are met and maintained. Planet is committed to evaluating existing programs and adapting or introducing new initiatives as the world, our communities, our business and our Environmental Stewardship Objectives evolve.
