

Planet Explore Sweepstakes

- 2. Eligibility. Subject to the additional restrictions below, the Planet Explore Sweepstakes (the "Sweepstakes") is open to legal U.S. residents of the 50 United States (excluding Puerto Rico) and the District of Columbia who, at the time of entry, have reached the age of majority in their state of residence. Employees of Planet Labs PBC, or its affiliates or subsidiaries (collectively the "Planet"), and immediate family members and/or those living in the same household, and public employees at any level of government are not eligible to enter or win.
- 3. Sweepstakes Period. The Sweepstakes will begin on March 15, 2023 at 9:00 AM (P.T.) and end on March 31 2023, at 8:59 AM (P.T.)

The decisions of Planet regarding the selection of prize recipients and all other aspects of the Sweepstakes shall be final and binding in all respects. Planet will not be responsible for typographical, printing or other inadvertent errors in these Official Rules or in other materials relating to the Sweepstakes. After voting, you will be prompted to opt-in to enter the Sweepstakes by providing your email address. Your computer must accept cookies or any successor or similar technology, which may be used for the purpose of entry tracking. Ad blocking software on your computer needs to be disabled so that it doesn't interfere with processing your entry.

No methods of participation other than the methods specifically described



herein will be accepted. Planet is not responsible for lost, late, misdirected or incomplete entries or unsuccessful attempts to participate. All entries become property of Planet and none will be returned. Incomplete entries will not be eligible. Limit one (1) entry per person, per mailing address, and per email address.

- 6. Odds: The odds of winning depend on the number of eligible entries received.
- 7. Prize Winners. Planet will use a random number generator to select numbers that correspond to the entries to select two (2) winners for one (1) ticket ("Ticket") each for admission to Planet Explore 2023 in Washington, D.C. on April 12-13, 2023. The Ticket does not include travel or expense reimbursement. All costs of travel will be borne exclusively by the winners.
- 8. Notification and Acceptance. Ticket winners will be notified on or about April 1, 2023. Planet will email them at the email address provided on the entry form. Failure to reach any recipient by email after three (3) attempts may result in disqualification of the associated recipient, forfeiture of his or her interest in the Ticket, and selection of a substitute recipient from among all remaining eligible entries. Recipients may waive the right to receive the Ticket. Tickets are nonassignable and nontransferable. No substitutions allowed by recipients. Recipients are solely responsible for reporting and payment of any taxes on Tickets. Recipients may be required to complete an affidavit of eligibility/liability and publicity release (except where prohibited by law) which must be returned as directed by Planet. Failure to sign and return the affidavit or release within three days from receiving it, or to comply with any term or condition of these Official Rules, may result in the recipient's disqualification, the forfeiture of his or her interest in the gift card, and the award of the Ticket to a substitute recipient. Tickets not claimed by eligible recipients in accordance with these Official Rules will not be awarded and will remain the property of Planet.

or other causes beyond the reasonable control of Planet which corrupts or impairs the administration, security, fairness or proper operation of the Sweepstakes, Planet reserves the right in its sole discretion to suspend, modify or terminate the Sweepstakes. Should the Sweepstakes be terminated prior to the stated expiration date, Planet reserves the right to award prizes based on the entries received before the termination date. Planet will not be responsible for incomplete, lost, late, misdirected or illegible entries, or for failure to receive entries or votes or other electronic communications due to transmission failures or technical failures of any kind, including, without limitation, malfunctioning of any network, hardware or software, whether originating with sender or Planet. The authorized account holder of the e-mail address submitted at time of entry will be considered the entrant. An "authorized account holder" shall mean the natural person assigned to such email account by the internet service provider, online service provider, or other organization responsible for assigning e-mail addresses for the domain associated with such e-mail account (collectively, ISP). A potential Ticket winner may be requested to provide proof that they are the authorized account holder. In the event of a dispute, all online entries will be deemed to have been submitted by the owner of the ISP account from which they were sent. For these purposes, an ISP account holder shall mean the natural person assigned to such ISP account by the internet access provider, online service provider or other organization responsible for assigning ISP addresses for the domain associated with such ISP account. Any questions regarding the number of entries, or votes submitted or the owner of an ISP account shall be determined by Planet in its sole discretion.

10. Construction. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision.
